AMÉRICA MÓVIL, S.A.B. DE C.V., a *sociedad anónima bursátil de capital variable* organized under the laws of the United Mexican States (the “Company”), announced that its offer to exchange (i) all of its outstanding unregistered U.S.\$750,000,000 3.625% Senior Notes due 2015 (the “Original Notes due 2015”) for its registered 3.625% Senior Notes due 2015 (the “Exchange Notes due 2015”); (ii) all of its outstanding unregistered U.S.\$2,000,000,000 5.000% Senior Notes due 2020 (the “Original Notes due 2020”) for its registered 5.000% Senior Notes due 2020 (the “Exchange Notes due 2020”); and (iii) all of its outstanding unregistered U.S.\$1,250,000,000 6.125% Senior Notes due 2040 (the “Original Notes due 2040”) for its registered 6.125% Senior Notes due 2040 (the “Exchange Notes due 2040” and, together with the Exchange Notes due 2015 and the Exchange Notes due 2020, the “Exchange Notes”) expired at 5:00 p.m., New York City time, on August 25, 2010. As of the close of business on August 31, 2010, the Company was advised by the exchange agent that (i) an aggregate of U.S.\$750,000,000 Original Notes due 2015 was tendered in exchange for an equivalent of amount of Exchange Notes due 2015 and an aggregate of U.S.\$0 principal amount of the Original Notes due 2015 remains outstanding; (ii) an aggregate of U.S.\$1,998,590,000 Original Notes due 2020 was tendered in exchange for an equivalent of amount of Exchange Notes due 2020 and an aggregate of U.S.\$1,410,000 principal amount of the Original Notes due 2020 remains outstanding; and (iii) an aggregate of U.S.\$1,234,000,000 Original Notes due 2040 was tendered in exchange for an equivalent of amount of Exchange Notes due 2040 and an aggregate of U.S.\$16,000,000 principal amount of the Original Notes due 2040 remains outstanding.

The Exchange Notes have been accepted by Clearstream and Euroclear. Application has been made to list the Exchange Notes on the Official List of the Luxembourg Stock Exchange and to trade on the Euro MTF market of the Luxembourg Stock Exchange.
