We are the most used internet search printernet search traffic in China in 2011, according to iResearch Consulting Group, a market research firm. Our "Baidu" brand received the brand in China in BrandZ Top50 Most Valuable Chinese Brands 2012, a study of the top 50 most valuable Chinese brands published by M strategy research firm.

We serve three types of online participants and have achieved significant scale and diversity in our business:

Customers. We deliver online marketing services to a diverse customer base operating in a variety of industries. Payments for Consent

Events of Default

The trustee in its various capacities assumes no responsibility for the accuracy or completeness of the information concerning the Con party referenced in this prospectus or any prospectus supplement or for any failure by the Company or any other party to disclose events that significance or accuracy of such information.

Whenever the trustee shall have discretion or permissive power in accordance with the indenture or the law, the trustee may decline to approval by the holders and shall have no obligation to exercise the same unless it has received pre-funding, been indemnified and/or provid against all actions, proceedings, claims, actions or demands to which it may render itself liable and all costs, damages, charges, expenses an doing. ENFORCEABILITY OF CIVIL LIABILITIES

We are incorporated in the Cayman Islands because of the following benefits found there:

- political and economic stability;
- an effective judicial system;
- a favorable tax system;

However, certain disadvantages accompany incorporation in the Cayman Islands. These disadvantages include:

Our constituent documents do not contain provisions requiring that disputes, including those arising under the securities laws of the U directors and shareholders, be arbitrated.

Substantially all of our current operations are conducted in China, and substantially all of our assets are located in China. We have ap which is located at 111 Eighth Avenue, 13th Floor, New York, NY 10011, as our agent upon whom process may be served in any action brou of the United States. A majority of our directors and officers are nationals or residents of jurisdictions other than the United States and a subs located outside the United States. As a result, it may be difficult for an investor to effect service of process within the United States upon these them judgments obtained in United States courts, including judgments predicated upon the civil liability provisions of the securities laws of t United States.

Maples and Calder, our counsel as to Cayman Islands law, and Han Kun Law Offices, our counsel as to PRC law, have advised us that courts of the Cayman Islands and China, respectively, would:

- recognize or enforce judgments of United States courts obtained against us or our directors or officers predicated upon the civil laws of the United States or any state in the United States; or
- entertain original actions brought in each respective jurisdiction against us or our directors or officers predicated upon the sec state in the United States.

Maples and Calder has advised us that there is no statutory recognition in the Cayman Islands of judgments obtained in the United Stat Islands will in the circumstances described below, recognize and enforce a non-penal judgment of a foreign court of competent jurisdiction v there is no binding authority on this point, this is likely to include, in certain circumstances, a non-penal judgment of a United States court imp civil liability provisions of the U.S. federal securities laws.

Maples and Calder has further advised us that a judgment obtained in the United States will be recognized and enforced in the courts of without any re-examination of the merits of the underlying dispute, by an action commenced on the foreign judgment debt in the Grand Court of judgment (1) is given by a foreign court of competent jurisdiction; (2) imposes on the


