Although the global economy continues to expand, weakening financial market sentiment, the potential exit of the United Kingdom from the European Union (Brexit), trade policy uncertainty and concerns about China's outlook weigh on global economic prospects. Financial conditions in advanced economies continue to be tightened. Equity valuations have generally been pared back with diminished optimism about earnings prospects based on escalating trade tensions and expectations of slower global growth. Major central banks		



BANK have also moved to adopt a more cautious approach. While the U.S. Federal Reserve raised the target range for the federal funds rate in December 2018, it signalled a more gradual pace of rate hikes in 2019 and 2020. In line with earlier communications, the ECB ended its net asset purchases in December 2018. However, it also confirmed that monetary policy would remain amply accommodative, with no increase in policy rates until at least the summer of 2019, and full reinvestment of maturing securities continuing well past the first rate hike. The outlook for the economy in the Netherlands remains relatively positive, but risks to this outlook remain. BNG Bank's business is impacted generally by the business and economic environment in which it operates, which itself is impacted by factors such as changes in interest rates, securities prices, credit and liquidity spreads, exchange rates, consumer spending, business investment, real estate valuations, government spending, inflation, the volatility and strength of the capital markets and other de-stabilising forces such as geopolitical tensions or acts of terrorism.
