

FINAL TERMS

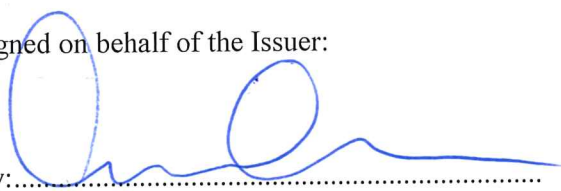
