

## FINAL TERMS

### **IMPORTANT – PROHIBITION OF SALES TO EEA AND UK RETAIL INVESTORS**

- The Notes are not intended, to be offered, sold or otherwise made available to and should not be offered, sold or otherwise made available to any retail investor in the European Economic Area (the "**EEA**") or the United Kingdom (the "**UK**").
