As such, Standard & Poor's, Moody's and Fitch are included in the list of credit rating agencies published by the European Securities and Market Authority on its website in accordance with the CRA Regulation

([www.esma.europa.eu/supervision/credit-ratingagencies/risk](http://www.esma.europa.eu/supervision/credit-ratingagencies/risk)).

As defined by Standard & Poor's, an “A” rating means that the Issuer's capacity to meet its financial commitment on the obligation is strong but somewhat susceptible to adverse economic conditions. The addition of a plus (+) sign shows relative standing within that rating categories.

As defined by Moody's, obligations rated “Aa3” are judged to have a high grade credit quality and thus subject to very low credit risk. The modifier 3

indicates a ranking in the lower end of that generic rating category.

As defined by Fitch, an “AA” rating denotes expectations of very low default risk. It indicates very strong capacity for payment of financial commitments. This capacity is not significantly vulnerable to foreseeable events. The modifier (-) is appended to denote relative status within this category.
