Redemption Date(s):	Quarterly, on the 29 th day of January, April, July and October commencing July 29, 2009
Interest Rate:	The Medium-Term Notes bear interest at different fixed rates, during different periods. (See "Step Interest Rates" herein.)
Frequency of Interest Payments:	Semiannually, in arrears, commencing October 29, 2009
Interest Payment Dates:	April 29 and October 29
Principal Payment:	At maturity, or upon redemption
