The Fixed Rate Bonds described herein (the "Bonds") were sold to Cantor Fitzgerald & Co, Daiwa Capital Markets America Inc, INTL FCStone Financial Inc. - BD Rates Division and Incapital LLC (the "Dealers"), as principals, for resale to investors at varying prices according to prevailing market prices at the time of resale as determined by the Dealers. Terms set forth below unless otherwise defined have the meaning ascribed to them in the Offering Circular.

**Principal Amount:** \$48,000,000

**Denomination:** \$1,000 and integral multiples of \$1,000 in excess thereof

**Issue Price:** 100.000%

**Issue Date & Settlement Date:** February 10, 2017

**Maturity Date:** February 10, 2025

**Interest Rate:** 2.550%

**Day Count Basis:** Interest shall be computed on the basis of a 360-day year consisting of twelve 30-day months.

**Interest Payment Dates:** Each February 10 and August 10, beginning on August 10, 2017, and the Maturity Date

**Redemption:** The Bonds are not subject to redemption prior to the Maturity Date.

**Reopenings:** The outstanding principal amount of this issue may be increased from time to time.

**Underwriting Concession:** 0.273007%

**Selling Concession:** 0.125%
