ING Bank N.V.

**Issue of €50,000,000 2 Year Floating Rate Notes due January 2017 (the "Notes")
(to be consolidated and form a single series with the €250,000,000 2 Year Floating Rate
Notes due January 2017 issued on 12 January 2015, the "Existing Notes")
under the €55,000,000,000 Debt Issuance Programme**

The Base Prospectus referred to below (as completed by these Final Terms) has been prepared on the basis that any offer of Notes in any Member State of the European Economic Area which has implemented Directive 2003/71/EC, as amended from time to time (the "**Prospectus Directive**"), (each, a "Relevant Member State") will be made pursuant to an exemption under the Prospectus Directive, as implemented in that Relevant Member State, from the requirement to publish a prospectus for offers of the Notes.
